Introduction

PSBU SDG 5.1 Policy: Equal Access to Education and Opportunities

Policy Commitments:

- Guarantee gender equality in student admissions, scholarships, and progression.
- Monitor enrolment and completion rates to ensure parity between men and women.

- Work with schools and communities to encourage young women, especially from rural areas, to pursue higher education.

PSBU SDG 5.5 Policy: Women's Leadership and Participation

PSBU recognises the importance of women's representation in leadership and decision-making roles, both within the university and in society.

Allocate resources to support initiatives advancing women's empowerment. Ensure gender-sensitive approaches in all research, community outreach, and partnership agreements.

Promote gender equality as a central principle in collaborations with local and international institutions.



The **PSBU Gender Equality Committee**, in partnership with the **Quality Assurance Office**, will oversee the implementation of this framework. Annual monitoring will include gender-disaggregated data on enrolment, staffing, leadership roles, and research participation. Findings will inform future action plans to ensure continuous improvement.
